

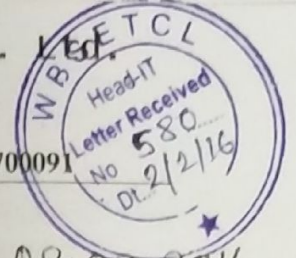


Applications of the employees are acceptable subject to the following conditions:

1. The **confirmed** employees having age upto 45 years as on 01.01.2016 may avail this opportunity to participate in the selection process.
2. Degree/Diploma obtained from Open University/ Distance Learning Mode/Part Time, Sandwich courses shall be allowed for departmental employees as applicable against the posts.
3. If selected, the appointment will be subject to satisfactory Vigilance report pertaining to present employment.

Relaxation in upper age limit of 27 years for professionally Semi Qualified Trainees having passed ICWA/CA intermediate examination is given by equivalent period of training undergone in WBSETCL only.
