For

"Supplying and laying of crushed stone over a layer of 75 mm cement, sand, jhama khoa mix (1:5:10) and allied works at Chanditala 132 KV Substation, WBSETCL, Hooghly."

WBSETCL invites single stage double folder bids from eligible and qualified bidders through e-tender for procurement of service as follows:

1.0 Brief scope of work:

- i) The work involves supply of all required materials, namely cement, jhama khoa, crushed stone, reinforcing steel etc as per technical specification and all other items required for completion of the work by the party.
- ii) Shallow excavation and preparation of bed with proper slope to maintain drainage for laying work of jhama khoa, cement followed by crushed stone as per specification.
- iii) Site cleaning including removal of all the residual material supplied by the party.
- iv) No deviation of stipulated terms and conditions of the tender document shall be allowed.

4.0 In the event of e-filing, intending bidder may download the tender documents from the website <http://wbtenders.gov.in>, <https://etender.wb.nic.in> directly with the help of Digital Signature Certificate. Necessary cost of tender documents (tender fees) amounting to Rs. 5,000/- (Rupees Five thousand) only may be remitted through Bank Draft / Pay Order issued from any scheduled bank in favour of the "West Bengal State Electricity Transmission Company Limited", payable at Kolkata and a scanned copy of the same to be uploaded to the specified folder in the e-tender portal.

5.0 All bids must be supported by bid security (EMD) for an amount of Rs. 62,000.00 (Rupees Sixty two thousand only) in the form of Demand Draft /pay order /Banker's cheque drawn in favour of "West Bengal State Electricity Transmission Company Limited" from any scheduled commercial bank, payable at Kolkata, or a Bank Guarantee from any scheduled commercial bank favouring WBSETCL which shall remain valid for a period of one hundred and eighty (180) days from the next day of bid opening date with a further claim period of thirty (30) days. Bid shall be rejected by the WBSETCL if the bidder fails to submit original Bank Guarantee /Demand Draft /Pay order against tender fees & Earnest Money Deposit (EMD) physically to the office of the Chief Engineer, Transmission (O&M), WBSETCL under sealed cover on or before the scheduled date & time as specified above.

6.0 Qualifying Requirements for bidders:

6.1 Following shall be the qualification requirements:

Technical

"The bidder should have the past experience of executing Works and services of similar nature of value not less than Rs. 37.02 Lac as a single contract in the preceding 5(five) financial years for government, central or state, or reputed power utilities of PSUs.

Services of similar nature shall be either crushed stone laying work or any other civil work consisting of masonry work and concrete (R.C or Plain) work."

Financial

a. Financial QR for the tender are as follows:

Net Worth:	Net Worth should be positive.
Liquid Asset:	Rs 15.43 lakh, Bidder should have liquid assets (L.A) or/and

	evidence of access to or availability of credit facilities to make good the shortfall in L.A, if any.
MAAT:	Rs 93.00 Lakh

Note: 1.) MAAT: Minimum average annual turnover for the best three years out of the last five financial years.

2.) 'Liquid Assets' shall be as per last audited accounts available.

6.2 The bidder shall furnish, as part of his bid, scanned copies of documents to be uploaded for establishing the bidder's qualifications. In particular, the following documents need to be uploaded by the bidder:

- a. List of contracts for similar Works and services executed in the past three years with copies of LoAs and execution status of each contract supported by client's certificate.
- b. Audited Annual Accounts of the company for the last three (3) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies)

- c. Attested Copies of (Insert the relevant certificate) *Sales Tax/ VAT registration certificate, Professional Tax Clearance Certificate, E.S.I and E.P.F registration numbers, PAN and/or TAN Card, Excise and Service Tax registration certificate.*

6.3 In addition to above, the bidder shall also be required to meet the eligibility conditions and submit a declaration as per Annexure: 5 of Section VI-A of the bidding documents

6.4 Notwithstanding anything stated herein, WBSETCL reserves the right to inquire and review the bidder's capability and capacity to execute the Works and services

7.0 WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding process without assigning any reasons there for and in such case no bidder shall have any claim arising out of such action.
