- 2.0 Brief scope of work:
- The work involves supply of all required materials, namely cement, reinforcing steel, bricks etc. and all other items required for completion of the work by the party.
  - Extension of Control Room Building and allied work** as per approved drawing, specification and as directed by the Controlling Officer.
  - Site cleaning including removal of all the residual material supplied by the party.
  - No deviation of stipulated terms and conditions of the tender document shall be allowed.

Cost of the Bidding document (non-refundable) as mentioned above in the form of a Demand Draft/Pay Order/Banker's Cheque drawn in favour of **“WEST BENGAL STATE ELECTRICITY TRANSMISSION COMPANY LIMITED”** from any scheduled bank payable at Kolkata shall have to be deposited physically at the office the Chief Engineer: (O&M) - II, D- Block, 10<sup>th</sup> Floor, WBSETCL, Bidyut Bhawan on or before **11.10.2018 up to 01.00 P.M.**
- 5.0 Downloading the bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents uploaded by the bidder
- 6.0 All bids must be supported by **bid security (EMD)** for an amount of **Rs. 31,000.00 /- (Rupees Thirty One Thousand Only)** in the form of Demand Draft /pay order /Banker's cheque drawn in favour of **“West Bengal State Electricity Transmission Company Limited”** from any scheduled commercial bank, payable at Kolkata , or a **Bank Guarantee** from any scheduled commercial bank favouring WBSETCL which shall remain valid for a period of one hundred and eighty (180) days from the next day of bid opening date with a further claim period of thirty (30) days. Bidders must submit the Bid security physically within the stipulated date as above at the office of the Chief Engineer: (O&M) – II, 10<sup>th</sup> Floor, D-Block, Bidyut Bhawan within the date as specified above and also to be documented along with the bid and submitted online. Non submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non-responsive.
- 7.0 Tender Fee are exempted for the bidder/bidders who have participated and submitted Tender Fee within stipulated timeframe in 1st call of this tender vide NIT NO: CE/O&M-II/KATWA/2018-19/16 dated.17.07.2018.

8.0 Bid shall be rejected by the WBSETCL if the bidder fails to submit original Bank Guarantee /Demand Draft /Pay order against tender fees & Earnest Money Deposit (EMD) physically to the office of the Chief Engineer, Transmission (O&M-II), WBSETCL under sealed cover on or before the scheduled date & time as specified above.

#### 9.0 **Qualifying Requirements for bidders:**

9.1. Following shall be the qualification requirements:

##### **a. Technical qualifying requirement:**

The bidder should have the past experience of executing Works and services of residential building construction or any other building work of value not less than Rs. **15.46 lakh** in the preceding 5(five) financial years for government, central or state, or reputed power utilities of PSUs

##### **b. Financial**

Financial QR for the tender are as follows:

Net Worth:	Net Worth should be positive.
Liquid Asset:	<b>Rs 8.00 lac</b> Bidder should have liquid assets (L.A) and/or evidence of access to or availability of credit facilities of equivalent amount.
MAAT:	<b>Rs. 46.50 lakh</b>

**Note: 1.) MAAT:** Minimum average annual turnover for the best three years out of the last five financial years.

**2.) 'Liquid Asset'** shall be as per the last audited accounts available.

9.2. The bidder shall furnish, as part of his bid, scanned copies of documents to be uploaded for establishing the bidder's qualifications. In particular, the following documents need to be uploaded by the bidder:

- a. List of contracts for similar Works and services executed in the past three years with copies of LoAs and execution status of each contract supported by client's certificate.
- b. Audited Annual Accounts of the company for the last three (3) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last three (3) years  
(in case of bidders other than companies)

**c. Copies of Professional Tax Clearance Certificate, E.S.I and E.P.F registration numbers, PAN and/or TAN Card, Registration Certificate (Form GST REG - 06) issued under Goods and Services Tax Laws.**

9.3. In addition to above, the bidder shall also be required to meet the eligibility conditions and submit a declaration as per Annexure: 5 of Section VI-A of the bidding documents

9.4. Notwithstanding anything stated herein, WBSETCL reserves the right to inquire and review the bidder's capability and capacity to execute the Works and services

10.0 WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding process without assigning any reasons there for and in such case no bidder shall have any claim arising out of such action.
