2.0 Brief scope of work:

- i) The work involves supply of all required materials, namely cement, reinforcing steel, bricks etc and all other items required for completion of the work by the party.
- ii) Execution of all work complete as per approved drawing, specification and as directed by the controlling officer.
- iii) Site cleaning including removal of all the residual material supplied by the party.
- iv) No deviation of stipulated terms and conditions of the tender document shall be allowed.

- 5.0 Downloading the bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents uploaded by the bidder
- 6.0 All bids must be supported by **bid security (EMD)** for an amount of **Rs. 49,000.00 /-** **(Rupees Forty nine Thousand only)** in the form of Demand Draft /pay order /Banker's cheque drawn in favour of **“West Bengal State Electricity Transmission Company Limited”** from any scheduled commercial bank, payable at Kolkata , or a **Bank Guarantee** from any scheduled commercial bank favouring WBSETCL which shall remain valid for a period of one hundred and eighty (180) days from the next day of bid opening date with a further claim period of thirty (30) days. Bidders must submit the Bid security physically within the stipulated date as above at the office of the Chief Engineer: (O&M) – I, 10th Floor, D-Block, Bidyut Bhawan within the date as specified above and also to be documented along with the bid and submitted online. Non submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of

inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non-responsive.

8.0 Qualifying Requirements for bidders:

8.1. Following shall be the qualification requirements:

a) Technical qualifying requirement: -

b) "The bidder should have the past experience of executing Works and services of similar nature of value not less than the amount of Rs. 35.00 lakhs as a single contract in the preceding 5(five) financial years for government, central or state, or reputed power utilities of PSUs. Services of similar nature shall be either crushed stone laying work or any other civil work consisting of masonry work and concrete (R.C or plain) work.
