- 1.0 **West Bengal State Electricity Transmission Company Limited** herein referred to as **WBSETCL** invites e-tender (Submission of Bid through **online**) through local competitive bidding (LCB) from eligible bidders for Engineering as required, electrical and civil construction, supply & delivery of materials, erection, dismantling and commissioning including transportation & insurance, storage in respect of the following work :-

Augmentation of 132/25 kV Transformer Capacity from (2 X 10) MVA to (2 X 30) MVA at Haldia 132/33 kV sub-station, WBSETCL on turn key basis

SCOPE OF WORK :

The work covered under this tender shall be but not limited to the following:-

- i. Dismantling of electrical equipments and civil foundations if required.
- ii. Construction of civil foundations as per specifications.
- iii. Fabrication, galvanizing and supply of structures for electrical equipments as per specification & price schedule.
- iv. Supply of all electrical equipments, panels and core cables and other accessories as per specifications and price schedule.
- v. Erection of all structures, equipments and control panels, laying of power cable including cable termination & complete earthing etc.
- vi. De-clamping of existing conductors and re-stringing of the same in new configuration including stringing of conductor and earth wire if necessary.
- vii. Testing, commissioning of all bays
- viii. Providing all necessary logistic support for testing of the equipments

Necessary cost of tender documents (tender fees) amounting to **Rs. 5,000/- (Rupees five thousand) only** may be remitted through Bank Draft / Pay Order issued from any scheduled bank in favour of the “**West Bengal State Electricity Transmission Company Limited**”, payable at Kolkata and a scanned copy of the same to be uploaded. Necessary Earnest Money (EMD) may be remitted through Bank Draft / Pay Order/Banker’s cheque issued from any scheduled bank in favour of the “**West Bengal State Electricity Transmission Company Limited**”, payable at Kolkata or Bank Guarantee from any scheduled Bank and also to be documented through e-filing. The original Bank Draft / Pay Order against tender fees and the original Bank Draft / Pay Order / Bank Guarantee against Earnest Money Deposit (EMD)(As statutory documents)

should be submitted physically (Offline) to the Office of The Chief Engineer:TR(O&M), WBSETCL under sealed cover on or before scheduled date & time as specified above.

- 4.0 All bids must be supported by **bid security (EMD)** for an amount of **Rs. 1.982 Lac (Rupees One Lac and Ninety Eight Thousand Two Hundred only)** in the form of Demand Draft /pay order /Banker's cheque drawn in favour of "**West Bengal State Electricity Transmission Company Limited**" from any scheduled commercial bank, payable at Kolkata , or a Bank Guarantee from any scheduled commercial bank favouring WBSETCL which shall remain valid for a period of two hundred and forty (240) days from the next day of techno-commercial bid opening date with a further claim period of ninety (90) days. Bid shall be rejected by the WBSETCL if the bidder fails to submit original Bank Guarantee /Demand Draft /Pay order against tender fees & Earnest Money Deposit (EMD) physically to the office of the Chief Engineer, TR(O&M) Department, WBSETCL under sealed cover on or before the scheduled date & time as specified above.

5. Qualifying Requirements for bidders:

Necessary documents shall have to be submitted by the bidder to comply the QR.

A. Technical QR :

The Bidder, who intends to participate in the Bid, shall have to comply the following criteria:

- 1) The Bidders must have experience of successful execution of at least two no. 66/33 kV / 66/11 kV / 25 kV TSS or higher voltage class 132/33 KV Transformer/Feeder bay in a running Sub Station during last 5 (five) years as on the date of NIT with or without supply of equipments /materials but including civil and electrical erection work and installation, testing and commissioning of bays. Such work must be in successful operation for not less than one year in any Indian Power utility as on the date of NIT.

The above information is to be supported by certificate stating successful completion and satisfactory performance certificate and Taking over Certificate [TOC] of the relevant contract executed

B. Financial QR :

- iv) The **Minimum Average Annual Turnover (MAAT)** of the Bidder for the best 3 (three) years out of the last 5 (five) financial years for which the audited accounts are available shall not be less than **Rs. 298.00 Lac.**
- v) **Net worth** at the end of last financial year shall be **positive.**
- vi) Bidder shall have **Liquid Asset (L.A)** and /or evidence of access to or availability of credit facilities of equivalent amount not less than **50.00 lakh** (Rupees Fifty lakh only).

C. Other requirement:

Bids may be submitted by a Registered Company that on its own meets all the qualifications, experience and requirements set forth in bidding document. Bidder shall also satisfy the following conditions:

- a) They shall possess a valid electrical contractor's license issued under the Act.
- b) All equipment offered for this tender shall be Type Tested and they should procure the equipments/materials from approved maker's list of WBSETCL.
- c) The "Must Conditions" to be met by the bidder have been further elaborated in the NIT. Bidders shall upload scanned copies of valid and authenticated documentation in support of his capability/experience/requirement and qualification.

Documentary Evidence in support of Technical QR.

1. List of purchase order references for similar supplies in the past five (5) years with copies of un-priced/priced purchase orders and execution status of each order supported by duly acknowledged delivery challans or excise duty gate passes or, client's certificate.
2. Confirmation regarding availability of in-house inspection/ testing facilities or access through other government approved agencies for performing inspection/ testing.
3. Performance Certificates from the user for successful operation of similar equipment.
4. Copies of Type Test Certificate of the Equipment / Materials included in the scope of supply as per relevant IS / IEC.

Documentary Evidence in support of Financial QR

1. Audited Annual Accounts of the company for the last three (3) years (in case of companies) or IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies)
2. Copies of TAN Card, Excise registration certificate, valid Sales Tax / VAT registration certificate.
3. If applicable, Copies of Service Tax Registration certificate.
Or
4. In case the bidder is a small service provider in terms of Finance Act 1994, then he has to furnish one certificate along with his Bid Documents in the following manner:- "That our Firm is a small Service Provider in terms of the Finance Act 1994 & we need not be registered with the Superintendent of Central Excise under Service Tax provision."

In addition to above, the bidder shall also be required to meet the eligibility conditions and submit an affidavit as per Annexure: 6 of Section V-A of the bidding documents

A. Completion Period :

- A. The total contract shall have to be completed by 180 days from the date of placement of LOA. The delivery of the total materials shall have to be completed by clear 180 days from the date of placement of the LOA. The delivery schedule given hereunder is

inclusive of the period required for conducting type tests, routine tests and acceptance tests as required by the WBSETCL.

- B. The place of delivery should be Haldia132KV Sub-Station, WBSETCL.
- C. Construction job shall have to be taken within one month from the date of placement of LOA.
- D. The successful bidder shall submit L2 network and get approval from the ordering authority to confirm the compliance of time schedule of the contract.

6. Personnel Capability:

The bidder must have full-fledged set up for executing similar projects in power utility. Details of execution set up to be deployed by the bidder shall be furnished in their offer. Project Management team shall be headed by a Project Manager who shall have at least 2 (two) years' experience in execution of such contract of comparable nature. He shall be stationed at work site

Issuance of bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during Technical bid evaluation based on data/documents submitted by the bidder. No request for sending the bid documents by post or by Courier Service shall be entertained. Bid documents are not transferrable.

- 7. The purpose of the pre-bid meeting will be to clarify the scope of supply, and any issues regarding the bidding documents and the Technical Specifications, if raised at that stage by the bidders. The WBSETCL shall not be under any obligation to entertain /respond to suggestions made or to incorporate modifications sought for by the prospective bidders during the pre-bid meeting or thereafter.
- 8. All bids shall remain valid up to a minimum period of one hundred and twenty (120) days from the next day of price bid opening date.
- 9. WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding without assigning any reason thereof and in such case no bidder/ intending bidder shall have any claim arising out of such action.
