The original Demand Draft / Pay Order against tender fees & Bid Security (As per Annexure-6) [As Statutory Document] should be submitted physically (offline) to the Office of The Chief Engineer, Procurement Department, WBSETCL under sealed cover on or before the scheduled date & time as specified above.

- 2.0 Issuance of bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents submitted by the bidder. No request for sending the bid documents by post or by courier service shall be entertained. Bid documents are not transferable.
- 3.0 All bids shall remain valid up to a minimum period of 120 days from the next day of price bid opening date.
- 4.0 All bids must be supported by **bid security** for an amount of **INR 1,25,000 only (Rupees One Lakh and Twenty Five Thousand only)** in the form of Demand Draft / Pay Order / Banker's Cheque, payable at Kolkata drawn in favour of "WEST BENGAL STATE ELECTRICITY TRANSMISSION COMPANY LIMITED" from any scheduled commercial bank or a Bank Guarantee from any scheduled commercial bank favouring "WEST BENGAL STATE ELECTRICITY TRANSMISSION COMPANY LIMITED". The bid security shall be **valid for one hundred and eighty (180) days from the date of opening of bids with a claim period of another Thirty (30) days thereafter**. Bidders must submit the Bid security physically within the stipulated date as above at the office of the Chief Engineer (Procurement), 10th Floor, B-Block, Bidyut Bhawan and also to be documented along with the bid and submitted online. **Non submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non-responsive.**

5.0 Qualifying Requirements for bidders:

5.1 Following shall be the qualification requirements:

Technical

- a. The bidder should have the past experience of providing Works and services of similar nature of value not less than INR 75,00,000/- (Seventy Five Lakhs only) as a

single contract in the preceding 5 financial years for government, central or state, or PSUs or reputed private sector.

- b. The bidder should have the past experience of providing & maintaining successfully Email Solution, Website Hosting services during the preceding 5 years for at least one CPSU/ PSU/ Government Sector Organisation for minimum 500 Employees.
- c. The bidder should be able to provide [within Kolkata jurisdiction] facilities such as Space for hardware, A.C., fire protection, UPS system, redundant connections, generator backup for 24 hours, 365 days and other facilities as required for uninterrupted hosting of website and providing Email services for WBSETCL.

Financial

- a. Liquid Asset at the end of last financial year shall not be less than INR 6,25,000.00 [Rupees Six Lakh and Twenty Five Thousand only] . Liquid Asset shall be as per the last audited accounts available.
- b. Annual Turnover (turnover from business activities only) during any of the last three (3) financial years for which the audited accounts are available shall not be less than INR 25,00,000/- (Rupees Twenty Five Lakhs only).
- c. Net Worth at the end of last financial year shall not be less than INR 31,25,000/- (Rupees Thirty One Lakh and Twenty Five Thousand only).

5.2. The bidder shall furnish, as part of his techno-commercial bid, documents establishing the bidder's qualifications. In particular, the following documents need to be submitted by the bidder:

- a. List of contracts for similar Works and services executed in the past three years with copies of LoAs and execution status of each contract supported by client's certificate.
- b. Audited Annual Accounts of the company for the last three (3) years (in case of companies)
or
IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies)
- c. Copies of Professional Tax Clearance Certificate, E.S.I and E.P.F registration numbers, PAN and/or TAN Card, Registration Certificate (Form GST REG - 06) issued under Goods and Services Tax Laws.
- d. Self-Attested Copies of documents as proof of ownership of the space or proof of hiring of space by the Contractor, which will be used for collocation of the hardware, to be used for providing the required services as per the scope of the contract.

- 5.3. In addition to above, the bidder shall also be required to meet the eligibility conditions and submit a declaration as per Annexure: 5 of Section VI-A of the bidding documents
- 5.4. Notwithstanding anything stated herein, WBSETCL reserves the right to inquire and review the bidder's capability and capacity to execute the Works and services
- 6.0 WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding process without assigning any reasons there for and in such case no bidder shall have any claim arising out of such action.
