

- (b) The contractor must possess and submit copies of statutory compliances like Valid Electrical Contractor's License , Valid Supervisory License , Labour License , P.F. Registration Certificate , ESI/ Workmen's Compensation Registration Certificates and other necessary certificate as per statute.

2. FINANCIAL :

- (a) Copies of the Execution Orders for break-down restoration/planned maintenance works of EHV Sub-Stations for 220KV & 400KV voltage level directly under any STU, CTU, Reputed Power Utility & Reputed EPC or Turn-key contractor (end user should be STU or CTU) during any of the last 03(Three) Financial years for which the audited accounts are available amounting to not less than Rs. 2,00,000/-(Rupees Two Lakhs Only).
