2. Rent shall depend on actual carpet area under possession of the occupant

excluding common area / space etc.

3. The rent as applicable as per above table shall be payable by the employees to

the Board for occupation of quarters. At the same time their admissibility of House Rent

Allowance shall be restricted only to the extent of rent so fixed.

4. In case as per above table rent payable is found to be higher than actual House

Rent Allowance admissible to any employee, such rent shall be restricted to his maximum

admissibility of House Rent Allowance only.

5. No employee – occupant of quarters shall be required to pay any service charge

for occupation of quarters henceforth.

This order shall take effect from the financial year 2006-07.
