8.0 Qualifying Requirements for bidders:

- (i) The bidder must be the original manufacturer of quoted item/items (bidder intends to quote) and the bidder must have successfully delivered at least 25% (Twenty five percentage) of the offered quantity of quoted item/items in one financial year during the last 5 (five) years from the date of NIT.
- (ii) The similar or higher rated isolator of same voltage class (bidder intends to quote) must be in successful operation in any Indian Power Utilities for not less than 2 (Two) year as on date of NIT.
- (iii) Offered Isolators should be similar (*in voltage level with minimum current rating 1250 A*) with ones on which Type Test has been carried out as per relevant IS & IEC in Govt. Recognized/NABL accredited test laboratory. Complete set of type test reports shall have to be submitted along with the offered bid. The bidder who has no type test report shall have to submit one undertaking that before offering inspection call, they will perform the above Type Test free of cost without affecting the delivery schedule.
