3.0 WBSETCL invites single stage twofoldersbids from eligible and qualifiedbidders [*Any Bidder from a country which shares a land border with India will be eligible to bid only if the Bidder is registered with the Competent Authority as per order no. F.No.6/18/2019-PPD (Order Public Procurement no.1) dated 23/07/2020 and F.No.6/18/2019-PPD (Order Public Procurement no.2) dated 23/07/2020, issued by Public Procurement Division, Department of Expenditure, Ministry of Finance, Government of India (DoE Order).Registration should be valid at the time of submission of bids and at the time of Notification of Award.However, the aforesaid condition for registration of Bidders from countries (even if sharing land border with India) shall not be applicable to Bidders from such countries to which Government of India has extended lines of credit or in which Government of India is engaged in development projects*] through e-tender for procurement of following Equipment / Materials:

5.0 Uploading of bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents submitted by the bidder. No request for sending the bid documents by post or by Courier Service shall be entertained. Bid documents are not transferrable.

6.0 The purpose of the pre-bid meeting will be to clarify the scope of supply, and any issues regarding the bidding documents and the Technical Specifications, if raised at that stage by the bidders. The WBSETCL shall not be under any obligation to entertain / respond to suggestions made or to incorporate modifications sought for by the prospective bidders during the pre-bid meeting or thereafter.

7.0 The bidder must offer full tendered quantity of the relevant Equipment / Materials of any single item (say, Item-1 or Item-2 or any other item) or more than one items or all the items, the bidder intends to quote. Bid submitted by the bidders for quantity less than the tendered quantity specified above shall be liable for rejection. Also, the Bidder must upload the BoQ satisfactorily in accordance with their offered item(s); otherwise the bid may be summarily rejected.

8.0 All bids shall remain valid up to a minimum period of one hundred and twenty (120) days from the next day of price bid opening date.

10.0 Qualifying Requirements for bidders:

10.1. Following shall be the qualification requirements:

Technical

1. The bidder must be the original manufacturer of quoted item/items (bidder intends to quote) and the bidder must have successfully delivered at least 25% (twenty five percent) of the offered quantity of quoted item/items in one financial year during the last 5 (five) years from the date of NIT.
2. The similar or higher rated isolator of same voltage class (bidder intends to quote) must be in successful operation in any Indian Power Utilities for not less than 2 (two) years as on date of NIT.
3. Offered Isolators should be similar (in voltage level with minimum current rating 1250 A for 33 KV & 132 KV, minimum current rating 1600 A for 220 KV and minimum current rating 2000 A for 400 KV) with ones on which Type Test has been carried out as per relevant IS & IEC in Govt. Recognized/NABL accredited test laboratory. Complete set of type test reports shall have to be submitted along with the offered bid. The bidder who has no type test report shall have to submit one undertaking that before offering inspection call, they will perform the above Type Test free of cost without affecting the delivery schedule.
