The bidder should have the past experience of executing **Works and services similar nature such as Brick Work, RCC Work, Plastering, Painting Work, Tiles Work, Plumbing work of value not less than Rs. 8.91 lac excluding taxes** in the preceding 5(five) financial years under Central/State Government, or reputed power utilities of PSUs.
