1. *West Bengal State Electricity Transmission Company Limited (WBSETCL)* invites bids from the eligible bidders on turnkey basis through Domestic Competitive Bidding for supply & delivery, erection, testing and commissioning including transportation & insurance, storage in respect of Replacement of existing age-old Air conditioning machines by new Air conditioning machines at control room of NJP 220 KV Sub-Station under Siliguri Area Office, WBSETCL and allied work as defined in the bid document against **NIT No. SE&AM/SAO/A.C. MACHINE /2022-23/10, DATED 22.12.2022**
2. **SCOPE OF WORK** : The work covered under this Tender shall be but not limited to the following:-

A) **SUPPLY:-**

Supply and delivery of all outdoor and indoor equipments with all associated accessories etc. conforming to Technical Specification and approved drawings for Supply & installation of 05 Nos. 7.5 TR & 05 Nos. 5.0 TR non duct able split A.C. Machine at Control Room, 07 Nos. 2TR split A.C. Machine at PLCC Room & 02 Nos. 5.0 TR non duct able split A.C. Machine at Battery Room at NJP 220kV Sub- Station and allied work .

B) ERECTION:-

Erection of all outdoor and indoor equipment with associated all accessories complete as per requirement for successful commissioning of 05 Nos. 7.5 TR & 05 Nos. 5.0 TR non duct able split A.C. Machine at Control Room, 07 Nos. 2TR split A.C. Machine at PLCC Room & 02 Nos. 5.0 TR non duct able split A.C. Machine at Battery Room at NJP 220kV Sub- Station and allied work as per Technical Specification and approved drawings.

3. Estimated Cost for the Project: - **Rs. 21.72 Lac (Rupees Twenty One lakhs and Seventy Two Thousand) only.**
4. **WBSETCL** intends to finance this Project.

Cost of the Bidding document (non-refundable) as mentioned above in the form of a Demand Draft/Pay Order/Banker's Cheque drawn in favour of "**WEST BENGAL STATE ELECTRICITY TRANSMISSION COMPANY LIMITED**" from any scheduled bank payable at Siliguri Area Office, Siliguri and shall have to be deposited physically at the office the S.E & Area Manager: Siliguri Area Office, Administrative Building (1st Floor), WBSETCL, Siliguri on or before **19.01.2023 up to 01.00 P.M.**
7. Downloading the Bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents uploaded by the bidder
8. All bids must be accompanied by bid security for an amount of **Rs 21,720=00 [Rupees Twenty One Thousand Seven hundred and twenty only]** in the form of Demand Draft /Pay order /banker's Cheque/ Bank Guarantee and shall remain valid for a period of 240 days from the date of opening of Bids with a claim period of another 90 days thereafter. Bidders must submit the Bid security physically within the stipulated date as above at the office of the Siliguri and also to be documented along with the bid and submitted online. Non submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non responsive.

9. Non submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non responsive.

10. Qualifying Requirement for bidders:

In addition to the requirements stipulated under Section, Instruction to Bidders (ITB), the following shall also apply:

The Bidder must have to meet the following conditions:

A. Financial Capability:

- i) The **Minimum Average Annual Turnover (MAAT)** of the Bidder for the best 3 (three) years out of the last 5 (five) financial years for which the audited accounts are available shall not be less than **Rs. 33.00 Lac.**
- ii) **Net worth** at the end of last financial year shall be **positive.**
- iii) Bidder shall have **Liquid Asset (L.A.)** and/ or evidence of access to or availability of credit facilities of equivalent amount not less than **Rs. 5.00 Lac.**

B. Technical Capability and Experience:

The Bidder, who intends to participate in the Bid, shall have to comply all the following criteria:

- a) The bidder may be an original manufacturer/ an authorized dealer/supplier/ sole selling agent/Indian subsidiary of a foreign manufacturer.
- b) The original manufacturer may bid through a dealer, supplier, sole selling agent in India or Indian subsidiary, and for that an authorisation letter from such original manufacturer/ Valid Dealership certificate needs to be furnished by the bidder.

OR

A dealer, supplier, sole selling agent in India or Indian subsidiary may also bid directly and for that an authorisation letter from such original manufacturer/ Valid Dealership certificate needs to be furnished by the bidder.

- c) The Bidder must have supplied, erected, tested and commissioned at least **10 (Ten) Nos. 2.0 TR Split Type A.C. Machine** in one financial year during the **last 8 (eight) years** as on date of NIT.
- d) The bidder must have supplied, erected, tested and commissioned the equipment of same type and model to any Govt. Utility/ Govt. Power Sector/ Reputed Power Utility/ PSU in last three years.
- e) The bidder must have proven test reports of the offered equipment as per relevant IS/IEC from any Govt. Accredited Testing Laboratory.
- f) The bidder must have repairing centres in **WEST BENGAL** for complete restoration of defects of the offered equipment.

- g) The bidder must have to submit performance certificate of the equipment of same type and model from any Govt. Utility/ Govt. Power Sector/ Reputed Power Utility/ PSU for trouble free operation for three years.

The above information is to be supported by certificate stating successful completion and satisfactory performance certificate of the material supplied.

11. Completion period for the project is **120 (one hundred and twenty) days** from the date of placement of LOA.
12. The tender consists of 02 (Two) Price Schedules, one price schedule relating to Supply of equipment and materials etc. and other price schedule relates to corresponding erection of materials/ equipment etc. at the said location. Bidders are advised to offer their price for both schedules. In case any of the price schedules is left blank it will be considered that the bidder shall execute the total work as per total price offered for the other price schedule taken together.
13. WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding without assigning any reasons thereof and in such case no bidder/ intending bidder shall have any claim arising out of such action.
