Construction of foundation of different Switchyard equipment structures, construction of bituminous Road, crushed stone spreading over P.C.C and other allied work at Durgapur A- Zone 132/33 KV Substation under Durgapur Area Office, WBSETCL.

0.0 WBSETCL invites single stage double folder bids from eligible and qualified bidders through e-tender for procurement of service as follows:

1.0 Brief scope of work:

- i) Earthwork in excavation as per specification and drawings.
- ii) Construction of foundation of different 132 KV & 33 KV equipment structures, as per specification.
- iii) Construction of approx. 70 m new bituminous road and repairing works of approx. 100 m existing bituminous road within the Substation premises, as per drawings supplied by WBSETCL as well as technical specification.
- iv) Crushed stone spreading over P.C.C. as per technical specification.
- v) Supply of all required materials, namely cement, reinforcing steel, Coarse/Fine aggregates, bricks, Steel, cationic bitumen emulsion, crushed stone etc. and all other items required for completion of the work by the vendor.
- vi) Site cleaning including removal of all the residual material supplied by the party.

- 4.0 Downloading the bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents uploaded by the bidder
- 5.0 All bids must be supported by **Bid Security (EMD)** for an amount of **Rs. 36,000.00 (Rupees Thirty Six Thousand Only)** in the form of Demand Draft / Pay Order / Banker's Cheque drawn in favour of "**West Bengal State Electricity Transmission Company Limited**" from any scheduled commercial bank, Payable at Kolkata. Bidders must submit the Bid security physically within the stipulated date as above at the office of the Chief Engineer: (O&M) – II, 10th Floor, D-Block, Bidyut Bhawan within the date as specified above and also to be documented along with the bid and submitted online. Non submission of the acceptable bid security along with

prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non-responsive.

6.0 Bid shall be rejected by the WBSETCL if the bidder fails to submit original Bank Guarantee /Demand Draft /Pay order against tender fees & Earnest Money Deposit (EMD) physically to the office of the Chief Engineer, Transmission (O&M-II), WBSETCL under sealed cover on or before the scheduled date & time as specified above.

7.0 **Qualifying Requirements for bidders:**

7.1. Following shall be the qualification requirements:

7.2.

a. Technical Qualifying Requirement:

The bidder should have the past experience of executing works and services similar nature such as “Construction of foundation of 33 KV or 132 KV or 220 KV or 400 KV Switchyard equipment structures/ Construction of 33 KV or 132 KV or any higher voltage class Bays / Construction of foundation of Transmission Line Tower / Construction of residential or commercial Building of value not less than Rs. 21.60 lac in the preceding 5 (five) financial years under Central/ State Government, or reputed power utilities of PSU’s”.

b. Financial

Liquid Asset:	Rs 9.00 lac Bidder should have liquid assets (L.A) and/or evidence of access to or availability of credit facilities of equivalent amount.
MAAT:	Rs.54.00 lac

Note: 1.) MAAT: Minimum average annual turnover for the best three years out of the last five financial years.

2.) ‘Liquid Asset’ shall be as per the last audited accounts available.

- 7.3. The bidder shall furnish, as part of his bid, scanned copies of documents to be uploaded for establishing the bidder's qualifications. In particular, the following documents need to be uploaded by the bidder:
- a. List of contracts for similar Works and services executed in the past three years with copies of LoAs and execution status of each contract supported by client's certificate.
 - b. Audited Annual Accounts of the company for the last three (3) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies)
 - c. **Copies of Professional Tax Clearance Certificate, E.S.I and E.P.F registration numbers, PAN and/or TAN Card, Registration Certificate (Form GST REG - 06) issued under Goods and Services Tax Laws.**
- 7.4. In addition to above, the bidder shall also be required to meet the eligibility conditions and submit a declaration as per Annexure: 5 of Section VI-A of the bidding documents
- 7.5. Notwithstanding anything stated herein, WBSETCL reserves the right to inquire and review the bidder's capability and capacity to execute the Works and services
- 8.0 WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding process without assigning any reasons there for and in such case no bidder shall have any claim arising out of such action.
