- 6.0 All bids must be supported by **Bid Security (EMD)** for an amount of **Rs. 29,708.00 (Rupees Twenty Nine Thousand Seven Hundred Eight only)** in the form of Demand Draft /Pay Order /Banker's Cheque drawn in favour of **"West Bengal State Electricity Transmission Company Limited"** from any scheduled commercial bank, payable at Jalpaiguri, or a **Bank Guarantee** from any scheduled commercial bank favouring WBSETCL which shall remain valid for a period of one hundred and eighty (180) days

8.0 **Qualifying Requirements for bidders:**

8.1. Following shall be the qualification requirements:

a) Technical qualifying requirement: -

"The bidder should have the past experience of executing Works and services of civil construction work preferably at 400 KV / 220 KV / 132 KV Sub-Stations of value not less than the amount of Rs. 17.82 lakhs as a single contract in the preceding 5(five) financial years for government, central or state, or reputed power utilities of PSUs.

Note: 1.) MAAT: Minimum average annual turnover for the best three years out of the last five financial years.

2.) 'Liquid Asset' shall be as per the last audited accounts available.

a. List of contracts for similar Works and services executed in the past three years with copies of LoA's and execution status of each contract supported by client's certificate.
