1.0 WBSETCL invites single stage double folder bids from eligible and qualified bidders through e-tender for Biennial Maintenance Work as follows:

2.0 Brief scope of work:

- i) Operation & maintenance of HVW emulsifier system and fire hydrant system, pipe fittings, accessories to ensure auto mode operation of the system i.e. its fire hydrant point, coupling, branch pipes, hose pipe, deluge valve and strainers, cleaning & servicing of all fire fighting equipment at Sub-Station switch yard and pump house including risk protection contract with deployment of one trained personnel for fire fighting system at pump house round the clock in three (03) shift and one skilled supervisor in general shift ensuring his service availability at any time and as directed by the controlling officer, Kharagpur 400KV AO.
- ii) Routine maintenance & emergency operation and maintenance of one 250 KVA DG Set and its accessories for period including supply of Diesel for routine test purpose (**both at no load & Full load as per schedule**) at Kharagpur 400KV SS.
- iii) Routine & emergency checking, testing & maintenance of all Heat / Smoke / response detector with panes battery and chargers etc. installed inside Kharagpur 400KV SS control room, WBSETCL.
- iv) Operation & maintenance of fire hydrant system, pipe fittings, accessories to ensure auto mode operation of the system i.e. its fire hydrant point, coupling, branch pipes, hose pipe, cleaning & servicing of all fire fighting equipment at Sub-Station switch yard and pump house at Keshiary 132KV S/S.

b. The bidder should have the past experience of executing the subject mentioned maintenance and services work of value not less than **Rs.11.14 lakh** in the preceding 5(five) financial years for government, central or state, or reputed power utilities of PSUs.

c. Financial

Financial QR for the tender are as follows:
