0.0 WBSETCL invites single stage double folder bids from eligible and qualified bidders through e-tender for procurement of service as follows:

1.0 Brief scope of work:


- i) **Painting of boundary wall both inside & outside** as per specification.
- ii) **Painting of chain link fencing of the switchyard** as per specification.
- iii) **Tit-Bit repairing of chain link fencing, Concertina wire, boundary wall etc which includes replacements of angle section, R.B.T wire, brickwork, plastering etc** as per specification.
- iv) Supply of all required materials, namely paints, barbed wire, R.B.T, angle sections, cement, reinforcing steel, Coarse/Fine aggregates, bricks, granite etc. and all other items required for completion of the work by the vendor.
- v) Site cleaning including removal of all the residual material supplied by the party.

- 3.0 A complete set of bidding documents may be downloaded by any interested bidder. Cost of the Bidding document (non-refundable) as mentioned above in the form of a Demand Draft/Pay Order/Banker's Cheque drawn in favour of "**PURULIA AREA OFFICE, WBSETCL**" from any scheduled bank payable at Purulia shall have to be deposited physically at SE & AREA MANAGER, Purulia Area Office, WBSETCL on or before **22.05.2023 up to 01.00 P.M.**
- 4.0 Downloading the bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents uploaded by the bidder
- 5.0 All bids must be supported by **bid security (EMD)** for an amount of **Rs. 19800=00 /- (Rupees Nineteen Thousand Eight Hundred Only)** in the form of Demand Draft /pay order /Banker's cheque drawn in favour of "**West Bengal State Electricity Transmission Company Limited**" from any scheduled commercial bank, payable at Purulia. Bidders must submit the Bid security physically within the stipulated date as above at the office of the SE & AREA MANAGER, Purulia Area Office, WBSETCL within the date as specified above and also to be documented along with the bid and



submitted online. Non submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non-responsive.

6.0 Bid shall be rejected by the WBSETCL if the bidder fails to submit original Demand Draft /Pay order against tender fees & Earnest Money Deposit (EMD) physically to the office of the SE & AREA MANAGER, Purulia Area Office, WBSETCL under sealed cover on or before the scheduled date & time as specified above.

**7.0 Qualifying Requirements for bidders:**

7.1. Following shall be the qualification requirements:

7.2.

**a. Technical qualifying requirement:**

The bidder should have the past experience of executing Works and services of similar nature such as painting of boundary wall, fencing, Residential building of value not less than Rs. 11,82,693/- (In single contract) including taxes in the preceding 5(five) financial years under Central/State Government, or reputed power utilities of PSUs.

**b. Financial**

Financial QR for the tender are as follows:

<b>Net Worth:</b>	Net Worth should be positive.
<b>Liquid Asset:</b>	<b>Rs 19,71,155/-</b> Bidder should have liquid assets (L.A) and/or evidence of access to or availability of credit facilities of equivalent amount.
<b>MAAT:</b>	<b>Rs. 29,56,733/-</b>

**Note: 1.) MAAT:** Minimum average annual turnover for the best three years out of the last five financial years.

2.) **'Liquid Asset'** shall be as per the last audited accounts available.

7.3. The bidder shall furnish, as part of his bid, scanned copies of documents to be uploaded for establishing the bidder's qualifications. In particular, the following documents need to be uploaded by the bidder:

a. List of contracts for similar Works and services executed in the past three years with copies of LoAs and execution status of each contract supported by client's certificate.

b. Audited Annual Accounts of the company for the last three (3) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies)

c. **Copies of Professional Tax Clearance Certificate, E.S.I and E.P.F registration numbers, PAN and/or TAN Card, Registration Certificate (Form GST REG - 06) issued under Goods and Services Tax Laws.**

7.4. In addition to above, the bidder shall also be required to meet the eligibility conditions and submit a declaration as per Annexure: 5 of Section VI-A of the bidding documents

7.5. Notwithstanding anything stated herein, WBSETCL reserves the right to inquire and review the bidder's capability and capacity to execute the Works and services

8.0 WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding process without assigning any reasons there for and in such case no bidder shall have any claim arising out of such action.
