a. Technical qualifying requirement:

The bidder should have the past experience of executing **Works and services similar nature such as Construction work experience of control room building and others buildings of value not less than Rs. 14.92 lac excluding taxes** in the preceding 5(five) financial years under Central/State Government, or reputed power utilities of PSUs.

.b. Financial

Liquid Asset:	Rs 6.22 lac Bidder should have liquid assets (L.A) and/or evidence of access to or availability of credit facilities of equivalent amount.

Note: 1.) MAAT: Minimum average annual turnover for the best three years out of the last five financial years.

2.) 'Liquid Asset' shall be as per the last audited accounts available.

7.2. The bidder shall furnish, as part of his bid, scanned copies of documents to be uploaded for establishing the bidder's qualifications. In particular, the following documents need to be uploaded by the bidder:

- a. List of contracts for similar Works and services executed in the past three years with copies of LOAs and execution status of each contract supported by client's certificate.
