WBSETCL invites e-tender from eligible and qualified bidders for the engagement of Agencies for Annual Maintenance Contract for Non- Civil works on job contract basis in various establishments of WBSETCL for one year with provision of one-year further extension on satisfactory service at the same rate, terms & conditions.

**1.0** WBSETCL invites e-tender from eligible and qualified bidders for the engagement of Agencies for Annual Maintenance Contract for Non- Civil works on job contract basis in various Zone wise establishments of WBSETCL for one year with provision of one-year further extension on satisfactory service at the same rate, terms & conditions as per following scope of work:

**A. SCOPE OF WORK FOR HOUSEKEEPING &DEWEEDING**

- a) Herbicide + Deweeding within switchyard.
- b) Manual Deweeding within switchyard.
- c) Manual Deweeding other than switchyard.
- d) Cleaning of ceiling & wall of control room & office building including all light, fan, door, window.
- e) Sweeping & cleaning of all floor, stair, passage etc. Of control room & office building daily.
- f) Sweeping & cleaning of stair, common passage including wall, ceiling, door, window etc. of all building except control room & office building.
- g) Cleaning of roof of all building within s/stn premises.
- h) Cleaning of all road within s/stn premises sweeping.
- i) Cleaning and disinfected with bleaching powder of all drain.
- j) Cleaning & disinfected IPWC/urinals & channel/wash basin with phenol daily except one day/week and same are cleaning with acid once in a week. For control room & office building
- k) Cleaning & disinfected of all GI/PVC/R.C.C/masonry tank all capacity.
- l) Removing sludge from septic tank and soak well etc.
- m) Cleaning silt from inspection pit.
- n) Pump operator operates pump/pumps two times daily

**B. SCOPE OF WORK & SPECIFIC CONDITIONS:GARDENING**

- a. Cleaning
- b. Trimming of trees and cutting the branches.
- c. Pesticide spraying, regular watering, trimming, shaping, grass cutting and keeping the area clean in all aspects and to the satisfaction of the Client. During the summers the soil is to be mulched on top with straw and leaves to retain the humidity of the soil, for all kinds of lawns, tree pits, shrub beds etc. In case of all shade loving plants arrangement for shade, till the tree grow to form a canopy, using 50% shade green net to be mounted on poles. Plant is to be staked with a strong bamboo stake of size 2"dia to hold the plant straight against wind and size of stake should be bigger by 2' more than the planth eight.
- d. Supply manure/pesticides etc. as required on approved Rates.
- e. Removal of dry refuse and wet refuse obtained on cutting of lawn, trimming of plants, trees and from other horticultural services
- f. The lawn area/pots may increase or decrease due to any reason in the Campus, so the payment shall be paid on pro-rata basis.
- g. Maintenance of lawn areas
- h. Maintenance of hedges
- i. Replacement of plants
- j. Preparations of seasonal beds

The above works will be performed/allotted to selected agencies dividing the entire work(s) into 6 clusters described as below: -

- Zone 1 (KolkataTrans Zone) - ClusterA
- Zone 3 (SiliguriTransZone) - ClusterB
- Zone 5 (BerhamporeTransZone) - ClusterC

**3.0** Uploading of bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents submitted by the bidder. Bid documents are not transferrable.

**4.0** The purpose of the pre-bid meeting will be to clarify the scope of work, and any issues regarding the bidding documents and the Technical Specifications, if raised at that stage by the bidders. WBSETCL shall not be under any obligation to entertain /respond to suggestions made or to incorporate modifications sought for by the bidders during the pre-bid meeting or thereafter.

**5.0** **The bidder must offer full tendered quantity of the services of any single Zone (say, Zone-1 or Zone-3 or any other Zone) or more than one Zones or all the Zones, the bidder intends to quote. Bid submitted by the bidders for quantity less than the tendered quantity specified above shall be liable for rejection. Also, the Bidder must upload the BOQ satisfactorily in accordance with their offered Zone (s); otherwise, the bid may be summarily rejected.**

**6.0** All bids must be supported by **bid security (EMD)** for an amount of

***N.B.: The EMD value indicated in the e-tendering portal is only an ornamental value "1" and shall be read as indicated in Clause 6.0 of the detailed NIT. Separate EMD is to be submitted for participating in each zone. The PARTICIPATION DOCUMENT as per attached format is to be duly filled up and submitted in hard copy along with the EMD.***

**7.0** Bid shall be rejected by the WBSETCL if the bidder fails to submit original Bank Guarantee /Demand Draft /Pay order against tender fees & Earnest Money Deposit (EMD) physically to the office of the General Manager (HR&A), WBSETCL under sealed cover on or before the scheduled date & time as specified above.

**8.0 Qualifying Requirements for bidders:**

**8.1.** Following shall be the qualification requirements:

**A. Technical qualifying requirement:**

1. The bidder must have successful experience in the field of housekeeping, deweeding & gardening or similar services of at least 1 year out of last five years from the date of NIT in any running Sub-Station of Indian Power Utility.
2. The bidder should have done the work related to housekeeping, deweeding and gardening services or any other maintenance /construction works having cumulative order value amounting to **Thirty One Lacs rupees only in last five year from the date of NIT** in any running Sub-Station of Indian Power Utility for applying in each zone respectively.

**B. Financial qualifying requirements:**

i. **Liquid Assets (L.A)** as per the last audited accounts available should be as follows:

- a. **For Zone-1:** Rs. 12,24,000=00 [Rupees Twelve Lacs Twenty Four Thousand Only]
  - b. **For Zone-3:** Rs. 12,22,000=00 [Rupees Twelve Lacs Twenty Two thousand Only]
  - c. **For Zone-5:** Rs. 12,61,000=00 [Rupees Twelve Lacs Sixty One thousand Only]
- Bidder/WBSETCL shall have Liquid Asset (L.A) and/ or evidence of access to or availability of credit facility of equivalent amount.
  - **Against offer bid for more than one Zone, the L.A amount shall be the sum of the respective individual Zone L.A amount of the offered items as specified above.**

ii. **Minimum Average Annual Turnover(MAAT):**

MAAT for best three (03) years out of the last five (05) financial years excluding non-recurring item should be as follows:

- a. **For Zone-1:** Rs. 73,40,000=00 [Rupees Seventy Three Lacs Forty Thousand Only].
- b. **For Zone-3:** Rs. 73,29,000=00 [Rupees Seventy Three Lacs Twenty Nine Thousand only].
- c. **For Zone-5:** Rs. 75,66,000=00 [Rupees Seventy Five Lacs Sixty Six Thousand Only].

**Against offer bid for more than one Zone, the MAAT amount shall be the sum of the respective individual Zone MAAT amount of the offered items as specified above.**

iii. Net Worth should be positive.

**8.2.** The bidder shall upload, as part of his techno-commercial bid, documents establishing the bidder's qualifications to execute the Order to the satisfaction of WBSETCL. All documents required to establish bidder's financial and technical qualification must be submitted as part of techno-commercial bid. In particular, the following documents need to be uploaded by the bidder:

- a. The bidder should upload copy of valid trade license/ registration to operate the job of Maintenance /Housekeeping / Deweeding & Gardening services.
- b. Bidder should upload experience certificate of at least one year out of the last five years in the job of housekeeping, deweeding & gardening services in last five year from the date of NIT in any Govt. organization/ P.S.U / Reputed MNC/ or any organization of repute. [Applicability up to the extent of meeting TechnicalQR]
- c. Bidder should upload copy of at least one (1) work orders wherein they have successfully executed the job contract in the field of housekeeping, deweeding and gardening services or any other non-civil works in last 5 years from the date of NIT in any Indian Power Utility [Applicability up to the extent of meeting TechnicalQR].
- d. **Bidder should upload copy of at least one work related to housekeeping, deweeding and gardening services or any other non-civil maintenance works having order value of Rupees Thirty One Lacs only for applying in particular zone. If more than one zone then order value would be cumulative.**[Applicability up to the extent of meeting Technical QR].
- e. Satisfactory Performance Certificate for a minimum period of any two completed years within last three financial years (**2019-20, 2020-21 and 2021-22**) from at least one major clients for the work/services to conclusively establish that the bidder has satisfactorily performed the requisite work(s)/services as per requirement specified above in Annexure4B.
- f. Audited Annual Accounts of the company for the last Three (3) years (in case of companies) or IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies). [Applicability up to the extent of meeting FinancialQR].
- g. Self-declaration that the bidder should not have been debarred or blacklisted by any State or Central Govt/ PSU in India while executing similar nature of work. If any dispute is pending at any Court of Law or under any Arbitration/ similar process pending decision of debarring/ blacklisting, detailed information must be enclosed.
- h. The Bidder who has been delisted or debarred or Blacklisted by any State or Central Government/ PSU in India while executing similar nature of work shall not be eligible anyway.
- i. Copies of Income tax/ Professional Tax Clearance Certificate / P.T. (Deposit Challan)/ PAN card / GST Registration Certificate.
- j. Registered Deed of partnership Firm / Article of Association & Memorandum/ Certificate of Incorporation in India etc.
- k. Documents to provide evidence that head/ service / branch establishment/ office of the bidder is within WestBengal.
- l. The bidder should upload documents having valid Employee Provident Fund Registration Number
- m. The bidder should upload documents having valid ESIC Number.



n. The bidder should upload documents having valid License/Registration No. under the Contract Labour (R&A) Act, 1970, if applicable.

8.3. In addition to above, the bidder shall also be required to meet the eligibility conditions and submit a declaration as per Annexure: 5 of Section VI-A of the bidding documents

8.4. Notwithstanding anything stated herein, WBSETCL reserves the right to inquire and review the bidder's capability and capacity to execute the Works and services.

9.0 WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding process without assigning any reasons there for and in such case no bidder shall have any claim arising out of such action.
