DETAILED NOTICE INVITING TENDER

For

Renovation work including supply and installation of A.C. Machines at A, B,C & D Block of 9th Floor and A & D Block of 8th Floor of Vidyut Bhavan to provide Air Condition facility to working employees of WBSETCL. [Open Domestic Competitive Bidding]

WBSETCL invites single stage double folder bids from eligible and qualified bidders through e-tender for procurement of service as follows:

1.0 Brief scope of work:

- i) Taking out old and existing window AC, Steel window etc. and Re-fixing of Window AC after Supply, fitting & fixing of Aluminium window as per direction of controlling officer.
- ii) Supply & installation of A.C. Machines at A, B,C & D Block of 9th Floor and A & D Block of 8th Floor of Vidyut Bhavan to provide Air Condition facility to working employees of WBSETCL as per technical specification and direction of controlling officer.
- iii) Design, Supply & Installation of 415 V, 3Phase, Busbar, Distribution Board, Main switch, Laying of 1.1 KV Grade Cables from Main switch to Building Main Busduct etc as per technical specification and direction of controlling officer. .
- iv) Supply, fitting & fixing of Floor Mat & False ceiling as per technical specification and direction of controlling officer.
- v) Design, Supply, fitting & fixing of illumination system, Fire alarm etc into false ceiling as per technical specification and direction of controlling officer.
- vi) Renovation work i.e. modification of existing half partition to full, new aluminium partition, dismantling some old partition, some tit bit work etc as per direction of controlling officer.
- vii) The work involves supply of all required materials, namely cement, Aluminium Section, Painting, Wood Work, Air Conditioning Machine, Materials required for Electric Wiring, False Ceiling, Floor Mat and allied works etc. and all other items required for completion of the work by the party.
- viii) Return all dismantled/taking out material/fittings etc. to user department.
- ix) Site cleaning including removal of all the residual material supplied by the party.

- x) No deviation of stipulated terms and conditions of the limited tender document shall be allowed.

- 5.0 **Tender Fee are exempted for the bidder/bidders who have participated and submitted Tender Fee within stipulated timeframe in 1st call of this tender vide NIT NO: CE/(O&M)-II/VIDYUT BHAVAN/2022-23/29 dated:28.11.2022.**
- 6.0 Downloading the bidding documents shall not automatically construe that the bidder fulfils the Qualifying Requirements which shall be determined during bid evaluation based on data/documents uploaded by the bidder
- 7.0 All bids must be accompanied by **bid security (EMD)** for an amount of **Rs. 1,42,000/- (Rupees One Lakh Forty Two Thousand only)** in the form of Demand Draft /pay order/ Banker's cheque drawn in favour of "**West Bengal State Electricity Transmission Company Limited**" from any scheduled commercial bank, payable at Kolkata, or a Bank Guarantee from any scheduled commercial bank favouring WBSETCL which shall remain valid for a period of one hundred and eighty (180) days from the final bid submission date with a further claim period of thirty (30) days. Non submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non responsive.

- 8.0 Bid shall be rejected by the WBSETCL if the bidder fails to submit original Bank Guarantee /Demand Draft /Pay order against tender fees & Earnest Money Deposit (EMD) physically to the office of the Chief Engineer, Transmission (O&M-II), WBSETCL under sealed cover on or before the scheduled date & time as specified above.
- 9.0 **Qualifying Requirements for bidder**
- 8.10 Following shall be the qualification requirements:

A. Technical qualifying requirement: The bidder should have the past experience of executing **Works and services of similar nature such as Construction/ Renovation/Maintenance/ Interior decoration of commercial/Residential building with electrical works etc. of value not less than Rs. 71.00 lac including taxes (in a single contract)** in the preceding 5(five) financial years under Central/State Government, or reputed PSUs or reputed private sector (As main vendor

and not as part of a consortium or an associate and to be supported by the client completion certificate).

10.0 The bidder shall furnish, as part of his bid, scanned copies of documents to be uploaded for establishing the bidder's qualifications. In particular, the following documents need to be uploaded by the bidder:

- a. List of contracts for similar Works and services executed in the past three years with copies of LoAs and execution status of each contract supported by client's certificate.
- b. Audited Annual Accounts of the company for the last three (3) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies)

- c. **Copies of Professional Tax Clearance Certificate, E.S.I and E.P.F registration numbers, PAN and/or TAN Card, Registration Certificate (Form GST REG - 06) issued under Goods and Services Tax Laws.**
- d. **The vendor should have valid electrical supervisory licence for electrical wirings.**

10.1. In addition to above, the bidder shall also be required to meet the eligibility conditions and submit a declaration as per Annexure: 5 of Section VI-A of the bidding documents

10.2. Notwithstanding anything stated herein, WBSETCL reserves the right to inquire and review the bidder's capability and capacity to execute the Works and services

11.0 WBSETCL reserves the right to accept or reject any bid partly or fully or cancel the bidding process without assigning any reasons there for and in such case no bidder shall have any claim arising out of such action.
