




All bids must be supported by bid security (EMD) for an amount of Rs. 10,500=00/- in the form of Demand Draft /pay order /Banker's cheque drawn in favour of 'PURULIA AREA OFFICE, WBSETCL' from any scheduled commercial bank, payable at PURULIA , from any scheduled commercial bank favouring WBSETCL which shall remain valid for a period of one hundred and eighty (180) days from the next day of bid opening date with a further claim period of thirty (30) days. Bidders must submit the Bid security physically within the stipulated date as above at the Office of the Office of the SE & Area Manager, Purulia Area Office, Administrative Building, (Near Purulia 132 KV Sub Station Campus), Bongabari, PO- V. Non-submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non-responsive.

5.0 Qualifying Requirements for bidders:

5.1. Following shall be the qualification requirements:-



a. Technical Qualifying Requirement: The bidder must qualify the following criteria:

1. The bidder may be an original manufacturer / an authorised dealer/supplier/sole selling agent/Indian subsidiary of a foreign manufacturer.
2. The original manufacturer may bid through a dealer , supplier , sole selling agent in India or Indian subsidiary and for that an authorisation letter from such original manufacturer / Valid Dealership certificate needs to be furnished by the bidder.

OR

A dealer , supplier , sole selling agent in India or Indian subsidiary may also bid directly and for that an authorisation letter from such original manufacturer/ Valid Dealership certificate needs to be furnished by the bidder.

3. The bidder must have supplied erected tested and commissioned at least 05 (five) Nos 2.0 TR or higher capacity Ductable/Non –ductable AC machines in one financial year during the last 5(five) years as on date of NIE-T

4. The bidder must have supplied, erected, tested and commissioned the equipment of same type and model to any Govt Utility/Govt Power Sector/ Reputed Power Utility/ PSU in last three years.
5. The bidder must have proven test reports of the offered equipment as per relevant IS/IEC from any Govt. Accredited Testing Laboratory.
6. The bidder must have repairing centres in WEST BENGAL for the complete restoration of defects of the offered equipments.
7. The bidder must have to submit performance certificate of the equipment of same type and model from any Govt. utility. govt power sector/reputed power utility/PSU/ for trouble free operation for three years.

The above information is to be supported by certificate stating successful completion and satisfactory performance certificate of the materials supplied.


Note: 1.) MAAT: Minimum average annual turnover for the best three years out of the last five financial years.

2.) 'Liquid Asset' shall mean cash & bank balances and fixed deposits in the name of the bidder as certified by a Chartered Accountant on a date not more than one month before the bid opening date or shall be as per last audited accounts available.

- 5.3. The bidder shall furnish, as part of his bid, scanned copies of documents to be uploaded for establishing the bidder's qualifications. In particular, the following documents need to be uploaded by the bidder:
- a. List of contracts for similar Works and services executed in the past three years with copies of LoAs and execution status of each contract supported by client's certificate.
 - b. Audited Annual Accounts of the company for the last three (3) years (in case of companies)

or

IT Return duly acknowledged by the tax department for the last three (3) years (in case of bidders other than companies)




c. **Copies of Professional Tax Clearance Certificate, E.S.I and E.P.F registration numbers, PAN and/or TAN Card, Registration Certificate (Form GST REG - 06) issued under Goods and Services Tax Laws.**
