WBSETCL invites bids from **the eligible bidders through Domestic Competitive Bidding for survey, planning, design, engineering, erection (Laying), testing, and commissioning of OPGW Cable, by replacing existing Earthwire (Liveline installation) on various EHV Power transmission line -361 Km of WBSETCL for establishment of Reliable Communications system.**  
**Completion Period -12 Months.**

**2. SCOPE OF WORK:**

The broad scope of the procurement of this part include the survey, planning, design, engineering, manufacturing, supply, transportation, insurance, delivery at site, unloading, handling, storage, Supervision of live line erection/live line installation, splicing, termination, testing, training, and demonstration for acceptance, commissioning and documentation for:

- a) OPGW including all associated hardware accessories & fittings
- b) Fibre Optic Approach Cable including installation material.
- c) Fibre Optic Distribution Panels (FODP) & Joint Box
- d) Supply of spares.
- f) Test equipment as per BOQ.
- e) All other associated work/items described in the technical specifications and Tender Document.

**NOTE: Most of the OPGW fibre optic cables to be installed under this project under live line conditions, i.e. with all the circuits of the transmission line charged to their rated voltage. “The existing earth wire along with its hardware & fittings shall be dismantled & taken away by the contractor on installation of OPGW. This factor may be taken into consideration while quoting the price.”**

The Bidder must have a valid electrical license issued from state or central government authority for working in charged electrical installations.

The various sections of these specifications define the survey, design, performance, installation, testing & implementation for the fibre optic cable system.

**5.0 All bids must be accompanied by Bid Security for an amount of Rs. 26 Lakhs [Rupees Twenty Six Lakhs only]** in the form of Demand Draft /Pay order /banker's Cheque/ Bank Guarantee and shall remain valid for a period of 240 days from the date of opening of Bids with a claim period of

another 90 days thereafter. Bidders must submit the Bid security physically within the stipulated date as above at the office of the Chief Engineer (Procurement), 10<sup>th</sup> Floor, B-Block, Bidyut Bhawan and also to

be documented along with the bid and submitted online. Non-submission of the acceptable bid security along with prescribed cost of bidding documents as specified here, in a sealed cover or submission of bid security and cost of bidding document of inadequate value shall be rejected by the WBSETCL and in such cases bids shall be considered as non-responsive.

**6.0** Qualifying Requirement for bidders:

In addition to the requirements stipulated under Section-II, Instruction to Bidders (ITB), the following shall also apply:

**6.1 Technical:**

**6.1.1** Bids must be submitted by a private/public Company registered under Company Act 1956 or 2013 and its amendment thereto that on its own (**credentials of past experience as a JV partner shall not be considered**) meets all technical and financial Qualifications, experience and requirements set forth in the bidding document.

**6.1.2** The bidder must have executed independently on turnkey basis laying of at least **50 Kms of OPGW cable in live condition on EHV line of 132 KV or higher voltage** class during **last 7 years** with complete survey, design and engineering, with supply of OPGW, FODP, hardware and accessories, erection, stringing, sagging, testing and commissioning of the line. The bidder shall furnish satisfactory Completion/Operation certificate/Site accepted Tests (SAT) from the concerned authority (to be supported by Taking over Certificate).

**6.1.3** The bidder shall either have the manufacturing capability and routine test facility for OPGW at his own plant and who have designed, manufactured, type tested as per relevant IS/IEC with latest amendments and supplied at least in totality **100 KM of OPGW** during the last **FIVE financial years** in Indian power utilities from the date of NIT **OR** shall have procured OPGW from eligible reputed manufacturer who meet the above stated qualifications.

**6.1.4** OPGW offered shall have Type Test Certificates from accredited laboratory (accredited based on ISO/IEC Guide 25 / 17025 or EN 45001 by NABL. with latest amendments. The type test reports shall not be older than FIVE years/ shall not be older than SEVEN years WITH SPECIFIC DECLARATION THAT "DESIGN PARAMETERS OF OPGW SHALL REMAIN UNCHANGED".

**6.1.5 IF THE BIDDER IS AN EPC CONTRACTOR AND DOES NOT MEET THE TECHNICAL CRITERIA OF MANUFACTURER AS LAID DOWN IN SERIAL 6.1.3 and 6.1.4 ABOVE:**

**6.1.5 (a)** The bidder, who is an EPC Contractor, must undertake during bidding to purchase OPGW from reputed manufacturers. In this regard, the EPC Contractor must obtain authorization from at least 2 (TWO) reputed manufacturer **meeting the criteria in Serial 6.1.3 and 6.1.4 above** (preferably supplier of WBSETCL). In event of being successful EPC Vendor **with compliance of Serial no. 6.1.2**, the Bidder shall have to purchase OPGW only from any of the manufacturers proposed by him. Such authorisation must be supported by legally enforceable undertaking jointly with the OPGW manufacturer to guarantee quality, timely supply, performance, service support and defect liability obligations as specified in the relevant technical specification and general conditions of contract.

The entire responsibility for the successful completion of the work shall belong to the bidder.

**OR**

**IF THE BIDDER IS AN OEM AND DOES NOT MEET THE TECHNICAL CRITERIA OF ERECTION WORK AS LAID DOWN IN SERIAL 6.1.2:**

6.1.5 (b) The bidder, who is a manufacturer, must undertake during bidding to associate with at least two Erection contractors and obtain authorization from such Erection Contractor (at least two) having experience of laying of at least **50 Kms of OPGW cable** in live condition on EHV line of 132 KV or higher voltage class during last 7 years **meeting the criteria 6.1.2 in addition to compliance of Serial no. 6.1.3 and 6.1.4 above.** The Bidder shall have to associate with any one of the Erection contractors from the list of names it has furnished during bidding. Such authorisation must be supported by legally enforceable undertaking jointly with the Contractor to guarantee quality, timely erection, performance, service support and defect liability obligations as specified in the relevant technical specification and general condition of contract

The entire responsibility for the successful completion of the work shall belong to the bidder.

**The Bidder shall furnish valid and authenticated documents in support of his eligibility and Technical qualification as required above.**

### **6.2 Personnel Capability**

i) The bidder must have full-fledged set up for executing similar turnkey projects. Details of execution set up to be deployed by the bidder shall be furnished in their offer.

Project Management team shall be headed by a Project Manager (Engineering Graduate) with at least 10 (ten) years' experience in execution of such contract of comparable nature. He shall be stationed at work site.

### **6.3 Financial**

I. The **Net Worth** at the end of last financial year shall be not less than **Rs. 3.25 Crore (Rupees Three Crore Twenty Five Lakh only)**.

II. The **Average Yearly Turnover** over the last three financial years shall not be less than **Rs. 19.50 Core (Rupees Nineteen Crore Fifty Lakh only)**.

III. Liquid Assets (L.A) as per the last audited accounts available should be **Rs. 3.25 Crore [Rupees Three Crore Twenty Five Lakh Only]**. Bidder shall have Liquid Asset (L.A) and/ or evidence of access to or availability of credit facility of equivalent amount.

**7.0** WBSE TCL reserves the right to accept or reject any bid partly or fully or cancel the bidding without assigning any reasons thereof and in such case no bidder/ intending bidder shall have any claim arising out of such action.
